Stepping up enforcement capabilities

ESTABLISHMENT OF THE KENYA COAST GUARD SERVICE OPERATION CENTRE (XOC)

Go Blue provided critical support for the establishment of the Kenya Coast Guard Service (KCGS) Operation Centre. Now **running 24/7**, the KCGS Operation Centre benefited from a unique demand-driven **comprehensive assistance package** designed to support KCGS through every development steps of their Operation Centre.

SUPPORT TO FISHERIES ENFORCEMENT CAPABILITIES

The protection of marine resources is key to ensure the resilience of the blue economy sector in Kenya. Under the guidance of the Kenya Fisheries Service (KeFS), Go Blue developed a comprehensive set of activities to ensure a **sustainable fisheries management** along the Kenyan coast.

- Development of curricula on monitoring, control and surveillance
- ☐ Training of 134 Fishing Constable Guards and Fisheries Officers from the five coastal counties of Kenya
- Establishment of 32 coxswains for KeFS patrol operation at sea



Engaging coastal communities

Developed in partnership with the Kenya Coast Guard Service (KCGS), the Community Watch Programme is a first-of-its-kind pilot initiative implemented along the Kenya coast to **strengthen information exchange and interrelationship between Kenyan maritime agencies and coastal communities**. It relies on the assumption that safety and security at sea cannot be achieved without the involvement and commitment of local communities, who can notably serve as a valuable source of information for maritime law enforcement actors. If successful, the Community Watch Programme will be replicated across the Western Indian Ocean region, thereby further consolidating Kenya's frontrunner role on maritime security in the region.

DELIVERY OF SAFETY TRAININGS FOR FISHERS

In support of KCGS' engagement with coastal communities, the project has **trained 35 KCGS officers to deliver safety trainings** tailored to the needs of fishers. **81 Beach Management Units (BMUs) from all five Coastal Counties** have so far benefited from this initiative, which already represents more than **2500 fishers equipped and trained** by KCGS on safety at sea.

DEPLOYMENT OF THE USALAMA BAHARINI COASTAL APP

The Usalama Baharini Coastal App is an innovative smartphone application developed under the Indian Ocean Regional Information Sharing (IORIS) system to provide a direct channel of communication between fisher communities and the Kenya Coast Guard Service (KCGS) to report maritime incidents along the Kenyan Coast. Designed as a user-friendly tool with state-of-the-art functionalities, the Usalama Baharini Coastal App acknowledges and empowers fisher communities as critical players for ensuring the safety and security of the Kenyan Coast.





Supporting Search & Rescue operations

Incidents at sea are causing each year hundreds of casualties in Kenya. Together with the Kenya Maritime Authority (KMA), Go Blue has launched an **ambitious plan to overhaul the current Search & Rescue (SAR) organization** and raise the operational capabilities up to the best regional standards.

 Development of SAR contingency plans
 Procurement of 5 SAR boats
 Establishment of interagency SAR response teams
 Training on SAR operations



Strengthening interagency cooperation

In an environment with multi-faceted and interconnected threats, interagency cooperation is essential for agencies to maintain maritime security and safety in the territorial waters. This is why Go Blue has pledged to support **stronger interoperability and better cooperation among stakeholders** involved in Kenya's maritime governance.
